CONSULTANT QUESTIONS

Q1: "On Page 6 of the RFP for the referenced project; Item 4 Required Information; III. Item 7 Key Staff states; "It is the Prime's responsibility to clearly and accurately represent all information for Key Staff individuals (education, years of highway and/or bridge inspection/engineering experience, and licenses/certifications listed)." Please provide clarification that "highway and/or bridge inspection/engineering" is not required."


A1: **REPLACE** with the following:

It is the Prime/Joint Venture's responsibility to clearly and accurately represent all information for Key Staff individuals (education, years of experience, and licenses/certifications listed).

Q2: "Page 7 of the RFP, Item 4.d. In addition to the Key Staff's brief resumes required in Item #7 of the SF 255, provide a one (1) page resume for each of the four (4) proposed Key Staff, outlined above in Section 4. c. iii. Format is at the firm's discretion. Are these resumes to be submitted as a separate package, not bound, with the Expression of Interest?"

A2: **The additional one (1) page resumes for each Key Staff can be inserted in the Expression of Interest immediately following the SF 255 or in a separate section created just for the resumes.**
