CONSULTANT QUESTIONS

- Q1: The listed Consultant Services Required in the RFP do not align with the contract type (traffic structure engineering, inventory, inspection & design services). Can you please verify that the Consultant Services Required are the correct services desired for BCS 2021-10?
- A1: See Addendum #2, RLO1/RLR1.
- Q2: "In the "Required Information" Section B. SF 330 of the Request for Professional Services, Part I, Section G. is not listed (however, this is usually included as part of a typical SF 330 Part I), should we exclude Part I, Section G from our EOI submittal?"
- A2: Section G should be included.
- Q3: Section B.I. SF 330 Part 1, Section E of the advertisement states we are permitted five (5) pages for resumes, but only four key staff positions are listed. We are typically permitted one (1) page per key staff resume. Please clarify whether or not this five (5) page limit is correct. If so, is it up to the consultants to determine how we use the additional page?
- A3: See Addendum #2, RLO4/RLR4.

- Q4: For SF 330 Section F Example Projects: Can an example project be an open-end contract under which multiple relevant projects were completed? If so, can JV partners combine contracts from the same BCS series under one sample project? For example, can BCS 20XX-XXA and BCS 20XX-XXB be combined as one sample project?
- A4: NO. Each example project is treated individually.
