The Maryland Department of Transportation State Highway Administration (MDOT SHA) is pleased to forward its Americans with Disabilities Act (ADA) compliance status report to the Federal Highway Administration (FHWA). This letter highlights MDOT SHA's accomplishments and the efforts we have made over the six years, 2015-2021. As of December 31, 2021, MDOT SHA achieved ADA compliance for the following areas along our roadway system:

Between 2015 and 2021, the MDOT SHA reconstructed over 50 miles of sidewalk to meet ADA compliance through the Sidewalk Reconstruction for Pedestrian Access program under Fund 33.
