The State Highway Administration (SHA) is pleased to forward its Americans with Disabilities Act (ADA) compliance status report to the Federal Highway Administration (FHWA). This letter highlights SHA's 2023 accomplishments and efforts made during that calendar year.

The SHA constructed approximately 6.38 miles of sidewalk to meet ADA compliance through the Sidewalk Reconstruction for Pedestrian Access program under Fund 33. The attached report reflects nine projects that were completed in four counties, representing three of SHA's districts. As of December 31, 2023, SHA achieved ADA compliance for the following areas along our state roadway system:
