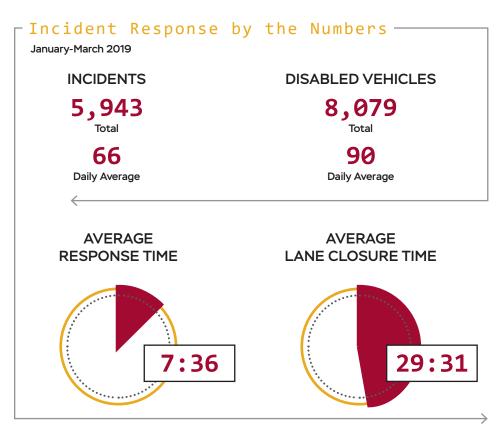
# About CHART Traffic Incident Management (TIM)

Emergency Traffic Patrols (ETPs) and Emergency Response Technicians (ERTs) have been helping motorists whose vehicles have become disabled and assisting at incidents along Maryland's highways since the 1980s. Although most people associate the yellow trucks with motorist assistance, their primary function is Traffic Incident Management. CHART enhances responder safety, coordinates the quick clearance of Maryland's travel lanes, improves interagency communications, provides updates to travelers, and reduces secondary crashes, all in an effort to keep motorists safe and Maryland moving on our roadways!

**CHART** operates 43 **Emergency Patrol vehicles**  Covering more than 2,000 lane miles of Maryland highways

# Our ETPs and ERTs:

- Assist a motorist every 16 minutes more than 37,400 assists a year
- Manage traffic at an incident once every 22 minutes
- ✓ Contribute to the prevention of an estimated 225-250 secondary incidents each year
- Contribute to drivers saving \$1.5 billion annually in fuel and delay costs.

#### **Emergency Responder** Technician (ERT) of the Year



Michael Meek began his career with MDOT SHA in 1988, and has been working as a full-time ERT since 2006. He has been consistent with attendance, customer service, traffic incident management, and maintains a great relationship with both internal and external partners. In 2017, Mike assisted 2,154 motorists and handled 1,222 incidents.

# Safety Minute: Maryland's "Move Over Law" Expanded to Protect Roadside Workers

In the Fall of 2018, Maryland's "Move Over Law" expanded to include service vehicles (transportation, construction, utility, and waste/ recycling) parked along a roadway in addition to emergency response vehicles and tow trucks. Drivers should attempt to move over if they see any of these vehicles pulled over or parked on the side of the road. If changing lanes cannot be done safely, motorists should slow down to a safe speed.

Recently, CHART ERT Danny Rice's vehicle was parked along I-270 during an incident response when a tractor trailer not only didn't move over, but weaved onto the shoulder. Thankfully, Danny was not in his vehicle at the



time and was safely out of harm's way, but his empty vehicle bore the brunt of the impact and luckily, shielded the responding Maryland State Police trooper from being hit. Please remember to slow down and move over when you see vehicles on the side of the road for everyone's safety!

# ALL LANES OPEN <a>> Innovative Recovery on I-97</a>

On March 5, 2019, an incident on Interstate 97 near Maryland Route 100 involving an overturned and loaded truck tractor/trailer combination and passenger car was cleared in less than three hours despite all of the challenges involved. The box trailer was fully loaded with paper products and became separated from the truck tractor, and the resulting crash caused two people to be transported to the hospital. The initial response by the Maryland State Police, Maryland Department of the Environment, CHART, and the MDOT SHA District 5 maintenance team closed three of four northbound lanes and half the southbound lanes.

Two towing companies arrived less than an hour after the accident, and a plan was devised to remove the damaged vehicles. The Maryland State Police agreed

to conduct a post-crash inspection at an off-site location, and soon after the arrival of the tow companies, recovery began.

The trailer, still fully loaded, was dragged from the median to the right shoulder, where a specialty trailer was remotely lowered and carefully backed under the damaged unit. This precision operation continued until the entire trailer and its contents were safely transferred and secured to the recovery trailer. All this work was orchestrated from lane #1 and the left shoulders in both directions of I-97. In less than three hours, all responders and damaged vehicles were cleared, and all lanes were re-opened before the afternoon rush hour great job to all involved!
