PURPOSE

To provide guidance for using the 2023 Maryland Department of Transportation State Highway Administration (MDOT SHA) Standard Specifications for Construction and Materials (2023) Specifications Book). The 2023 Specifications Book will be adopted for use on July 1, 2023.

SUMMARY

The 2023 Specifications Book is a compilation of the 2022 Specifications Book; new or revised Special Provisions Inserts (SPIs) approved for use between July 1, 2022, and June 30, 2023; and reference corrections or typographical corrections to the 2022 Specifications Book.
